2024 West Virginia State Youth USBC Open-Tournament Rules

- 1. WV State Youth USBC Open is certified, all USBC rules and regulations will be in effect.
- 2. Bowler must be a USBC youth member, and bowl in a WV USBC certified youth league.
- 3. Competition: March 2 @ 10 AM, March 3 @ 2 PM, March 9 @ 2 PM.
- 4. Squad times will be added if needed.
- 5. Competition shall be conducted in the following male and female division: **U8, U10, U12, U15, and U18**. All bowlers will bowl a 3-game series. Ages will be determined as of 8/01/2023. U8 will consist of bowlers whose birthdate is 8/1/2015 or later. U10 will consist of bowlers whose birthdate is 8/1/2013 thru 7/31/2015. U12 will consist of bowlers whose birthdate is 8/1/2011 thru 7/31/2013. U15 will consist of bowlers whose birthdate is 8/1/2005 thru 7/31/2008.
- 6. Handicap will be 100% of difference of 210.
- 7. Symbolic awards 1st, 2nd, 3rd in all divisions (**U8, U10, U12, U15, U18).**
- 8. All bowlers must wear proper attire. Dress code: NO shorts above the kneecaps, NO wearing of clothing depicting foul language or gestures. NO hats allowed, NO smoking or drinking of alcohol is allowed.
- 9. Bowlers will use their highest current certified average, with a minimum of 21 games as of February 1, 2024. If minimum games not reached, bowler will **use last season book average** with a minimum of 21 games. If a bowler is using last season's average, and, as of February 1, 2024, the bowler has an average of 10 pins or more higher for at least 12 games, then the bowler must use the current average. Any average not covered by the statements above, or any discrepancies in averages, will be reviewed on a case-by-case basis.
- 10. Check in time is at least one hour before scheduled bowling time. Anyone arriving **LATE** shall begin play and the score will count beginning with the frame being bowled. Preceding frames will be scored with a score of zero.
- 11. Only bowlers, score keepers and tournament officials will be allowed in the immediate bowling area.
- 12. Coaching is permitted but the BOWLER must come back to the coach or parent on the carpet area.
- 13. Bowlers are asked to bring shoes from their own center. U8 bowlers may wear bowling tennis shoes as long as they do not slide. The use of such substances as talcum powder, pumice, rosin, etc., on shoes that may alter the normal conditions of the approach is **STRICTLY PROHIBITED.**
- 14. Scholarship fee returned 100% Scholarship will be awarded as follows: all divisions Boys and Girls 1 out of 10. Scholarship will be held in the **USBC SMART FUND # 10174.**
- 15. Competitors will be allowed 10 minutes of practice time.
- 16. Claims for errors in scoring or general playing rules must be given to the tournament director no later than the start of the block or 30 minutes after the completion of competition. Questionable errors shall be decided by the tournament director. All other protest must be confirmed in writing to the tournament director before the awards are presented. Under this rule, each protest must be specific.
- 17. If a bowler cannot finish their game(s), they will receive zeroes for the remaining frame(s)/game(s).
- 18. This appeal or protest shall state briefly the grounds of the appeal or protest. The **West Virginia State USBC** board of directors will rule on any appeal or protest. The boards' decision will be final.
- 19. Tournament Director is responsible for verification of averages and memberships.
- 20. The tournament director has the right to disqualify a bowler if he or she violates USBC RULE 17d.
- 21. All Bowlers in the Host Zone MUST bowl the FIRST squad!
- 22. The WV State USBC board of directors will decide any questions not covered by these tournament rules.
